České dráhy, a.s. – Pricing of a 7-year Eurobond in the amount of EUR 500 million

České dráhy, a.s. yesterday priced a 7-year English law governed Eurobond in the amount of EUR 500 million. The coupon was set at 1.50% p.a. The expected settlement date is 23 May 2019. Three banks are involved in the issue: Citigroup and Erste Group as Lead managers and ING Bank as bookrunner.
